# **Emissions reduction targets**

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 90 tCO2e by 2030. This is a reduction of 43%

#### **Carbon Reduction Projects**

#### Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2023 baseline. The carbon emission reduction achieved by these schemes equate to 107.9 tCO2e, a 32% reduction against the 2023 baseline and the measures will be in effect when performing the contract

**Green Travel Policy:** Actively encourages the use of public transport, electric vehicles, and virtual delivery to minimise travel-related emissions. For Face-to-Face (F2F) delivery, escalla prioritises central training venues, minimising travel distances for attendees.

**Energy Efficiency in Training Delivery:** escalla aims to minimise the energy impact of training sessions by using energy-efficient platforms for virtual training and reducing printed materials. Digital resources will be promoted wherever possible to further reduce our <u>the</u> carbon footprint.

In the future we hope to implement further measures such as:

Digital Booking and Communication: escalla's intelligent scheduling and booking systems streamlines candidate registration, eliminating paper waste. escalla's These systems also supports communications, providing reminders and updates digitally to reduce the need for printed materials.
